Mr. Schultz expressed his concern regarding violation of civil liberties. Mr. Prisco would like the Police Chief to attend the next BoS meeting to further discuss.

### **UPDATE ON MWRA/READING/ANDOVER WATER DISCUSSIONS**

Mr. Mauceri gave a Power Point Presentation outlining MWRA versus Andover for the Town's water supply. Water Superintendent, Mark Clark, DWP Director, Andrew Lafferty, Town Engineer, Mike Soraghan, and Wright Pearce Consultant, Rob Williamson were in attendance.

- Mr. Mauceri The Town has spent approximately 2.4 Million Dollars on MWRA thus far, he would like to put a hold on capital expenditures to provide the Town time to work out a formal proposal with Andover.
- Mr. O'Leary If the Town puts off construction the costs will increase.
- Mr. Schultz Wants to see something more solid from Andover. There is a lack of commercial development in town because there is no sewer. The main objective is to get sewerage on Concord Street; it's the key to all the Towns growth. It is time to move on from Andover.
- Mrs. Manupelli The Town needs to continue discussions with Andover and doesn't think the Town should go off the path they are on.
- Mr. Prisco already made a decision, discussions with Andover should be over.
- Andrew Lafferty Rate is the big impact long term, the Town should continue discussions with Andover.
- Mr. Prisco Why didn't Andover take a formal vote on the proposal?
- Mr. Schultz has a trust issue with Andover. The Town would be a business partner with MWRA and a customer with Andover.
