#### TOWN ADMINISTRATOR REPORT

Mr. Gilleberto reported:

- 1. I have executed an agreement with Norse Environmental Services of Tyngsborough to conduct wetland flagging at the so-called affordable housing overlay properties, as requested by the Board and funded at Town Meeting.
- 2. I have again submitted the Town Center wastewater project, which would connect the municipal buildings in the Town Center to the Middle/High School wastewater treatment plant, to Senator Markey and Senator Warren for potential congressionally-directed funding. CIPC Chair Don Kelliher has also contacted Senator Markey to advocate for the application.

- 3. The Town has applied for Housing Choice designation through the state Department of Housing and Community Development. A Housing Choice Community Designation rewards municipalities that are producing new housing and have adopted best practices to promote sustainable housing development. This designation provides:
- a. Exclusive admission to the Housing Choice Community Grants Program.
- b. Priority access to various participating Housing Choice programs such as MassWorks, Complete Streets, MassDOT capital projects, and LAND and PARC grants. Housing Choice Communities are eligible to receive a 0.5% discount on the interest rate for State Revolving Fund loans.
- 4. Due to construction/renovations, Ipswich River Park Playground Area, Arthur J. Kenney Turf Field and Kid Spot Playground will be closed at various times over the next few months to allow for work to be done. Ipswich River Park: The IRP Playground area will be closed for construction from April 12th through April 28th. Playground structures will be removed and replaced with ADA compliant structures. Arthur J. Kenney Turf field: the turf field complex will be closed during the removal and replacement of the turf field. It is scheduled to take place mid-June through early August, 2023. Kid Spot Playground renovations, dates to be determined.
