REVIEW/DISCUSS JUNE TOWN MEETING WARRANT ARTICLES

Mr. Gilleberto reviewed the Warrant Articles. He informed the Board that Town Counsel reviewed the draft and that there are no changes to the revolving account maximum, therefore no action will need to be taken on revolving funds this year.

The proposed article pertaining to establishing a health insurance stabilization fund was discussed. Mr. Gilleberto recommended not establishing a separate fund. Mr. O'Leary stated the fund would be to take additional revenues and set them aside for a time when insurance rates spike. Mr. O'Leary further stated he wanted to keep the insurance rates budgeted at 7.5% rather than reduce it to 4.5% to save for when the Town is short some year. Mr. Schultz stated the Town shouldn't be using one time windfalls for operating budgets; that it is the worst thing to do. Ms. Rourke stated that the savings will not be transferred to free cash, it will be moved somewhere where the value is not lost, and that there are options without creating this fund. This article will be removed from the draft warrant.

An Article pertaining to Hillview golf cart leases was discussed. Mr. Gilleberto informed the Board that the Hillview Commission would like to enter into a 5 year lease agreement. Town Meeting approval is required for a 5 year lease agreement.

The Article pertaining to the plastic bag ban was discussed. Mr. Schultz stated that he will be meeting with the Reading Chamber of Commerce Chairman to discuss why Tewksbury revoked the plastic bag ban. The Board of Health will do more research on the ban.

An Article pertaining to zoning by-laws was discussed. Mr. O'Leary proposed this article in response to the pending 40B application for 20 Elm Street. This article would allow the opportunity to speak with the developer to see if there is an interest to do something other than the 200 unit development. Mr. Prisco explained that it is a creative way to get the developer to speak to the Town prior to submitting the application. A recommendation on the article could be made at Town Meeting.
