## **COVID 19 UPDATE**

Mr. Gilleberto states:

- He has been monitoring information received from the State today and he held a meeting today to discuss implementation of the phased reopening of municipal services. More information will be published on the Town Website regarding services, parks, etc.
- Mrs. Manupelli states that the TA is posting information on the Town Website, and the MA.gov website has information on the Executive Orders, the phased in plan, and a power point presentation.
- Mr. Gilleberto states information can also be found on the North Reading Town Hall Facebook page, and case updates are now on Thursdays or any time an update is necessary.
- Mr. O'Leary asked that the Health Agent take another look to help facilitate businesses being phased in; he wants to be able to do something locally to help businesses and wants it to work more smoothly, and wants to use flexibility.
- Mr. Schultz agrees to help where we can. He further stated some businesses are having staffing problems because employees are making more money staying home. He also stated CVS requested only 10 customers in the store at a time due to staffing issues.

## <u>CAPITAL IMPROVEMENT PLANNING COMMITTEE – REVIEW FISCAL YEAR</u> 2021 FUNDING RECOMMENDATIONS

Chairman of the Capital Improvement Planning Committee (CIPC), Don Kelliher, and Finance Committee member Abigail Hurlbut are present. Mr. Kelliher informs the Board of the following:

- There is uncertainty of funding due to state and local receipts.
- Received over Six Million Dollars in requests from Municipal, School, Water and Hillview.
- Went through the process of justification, field trips, and ranking. CIPC determined it is too much for this year, department heads were to determine what is critical:
  - o Boiler replacement at Town Hall;
  - o 1 truck for School and 1 truck for DPW;
  - o Stretcher system for Fire Department, can come out of ambulance funds;
  - Two Hundred and Twenty Thousand Dollar's worth of equipment for Hillview, which can come out of the enterprise fund, but will not be requested if the golf season doesn't produce enough revenue;
  - Water needs 2.3 Million Dollars for the distribution system and a truck, which can be paid for out of the enterprise fund.
  - o Road projects will be limited to what is available from Chapter 90 funds and the Two Hundred Thousand Dollars left over from last year.

Mr. Kelliher stated that deferred items from the FY2021 plan would be recommended for funding before October Town Meeting. Board Members responded as follows:

- Mr. O'Leary appreciates the efforts and recommendations.

- Mr. Wallner states the Committee has done a great job, but putting money into Town Hall is a concern where it might not be there in 5 years. Mr. Kelliher responded that the

new heating system would be able to be moved.

- Mr. Schultz states he has served on this Committee and they are doing a great job.
- Mrs. Gonzalez thanks the Committee for all their hard work.
- Mrs. Manupelli states she worked with the Committee this year and it is no easy task. She thanks the volunteers and states how much they are relied on for their financial, historical, and institutional knowledge.

#### **REVIEW FY 2021 TAX EXEMPTIONS/DEFERRALS**

Mr. Gilleberto informs the Board that information on this can be found on page 37 of the packet. Mr. O'Leary states he was contacted by a resident to see what exemptions might be available. Town Assessor Deb Carbone is present to inform the Board of exemptions and answer questions. Ms. Carbone states the following:

- Applications are due June 1<sup>st</sup> for this fiscal year, and currently, there is no one participating in the program.
- Can defer 100% or a portion of Real Estate Taxes at an 8% interest rate, there would be a lien on the property.
- Mr. O'Leary wants to be able to do something for the Seniors who are land rich and cash poor and allow them to stay in their homes and age in place.
- Mr. O'Leary states an adjustment needs to be made to the current income level of Twenty Thousand Dollars, maybe Sixty Thousand Dollars for a single or Ninety Thousand Dollars for a couple; he would like to put this on the June Town Meeting Warrant. The income requirements have not changed since 2008.
- Mr. Wallner would like to know what the other towns have set their income levels at and stated an 8% interest rate is greedy.
- Ms. Carbone stated Reading and Andover have a Forty Thousand Dollar income requirement and 5% interest.
- Mr. Schultz would like to know what the impact would be on local receipts.
- Mrs. Gonzalez has reservations about already being in financial trouble and thinks it
- needs to be explored in more detail.

- Mrs. Manupelli agrees with Mr. Schultz and Mrs. Gonzalez and stated there is already a program in place and would not be in favor of putting it on the Warrant unless it was fully vetted.
- Mr. O'Leary wants to put it on the Warrant and if it is determined there would be too much of an adverse impact, it could be passed over. He wants the Board to be availed of the opportunity to act on it if possible.
- Mrs. Manupelli stated this topic is on the agenda for the purpose of making the residents aware of the program.
- Mr. Wallner stated keeping Senior's in their homes is better fiscally for the Town and it's is not a drain on the taxes.
- Vincenzo Stuto, 122 Elm Street inquired if the Town would be able to obtain information to determine how many people could qualify for the exemption based on their income;
   Ms. Carbone responded she would not know where to get that information.

- Change to the Warrant is the addition of an article for funding for litigation for the 20 Elm Street site;
- Have not finalized language yet for Article 25; and
- Have language for Article 26 relative to effective military services for salary, seniority and leave allowances for Town Employees. The article will formalize a program that has been in place but not statutorily accepted by Town Meeting.
- Mrs. Manupelli states Article 25 is to establish a fund for historical buildings in Town and Article 26 has to do with Towns acceptance of military leave services. She further stated there are 33 Articles on the Warrant.

Mrs. Gonzalez requests revisiting the plastic bag ban by-law due to COVID19. Board Members responded as follows:

- Mr. O'Leary is not in favor of revisiting this.
- Mr. Wallner is not in favor of revisiting this.
- Mr. Schultz stated it should be put to the voters to keep people safe.
- Mrs. Manupelli stated it has already been put to the voters.
- Mrs. Gonzalez stated cloth bags are not sanitary and grocery store employees should not have to touch them.
- Mrs. Manupelli stated a petitioner cannot put a warrant article on the Warrant at this point, especially 2 weeks out.
- Town Clerk Barbara Stats responded it is well past the deadline and a citizen's petition cannot be accepted at this time, however the Board would be able to add an article. Ms. Stats further stated the deadline for adding a Citizens petition to the October Town Meeting would be by the Third Monday in August.

## REVIEW FY2021 REVENUE/EXPENSE PLAN AND DISCUSS DEPARTMENTAL REDUCTIONS

Mr. Gilleberto identifies steps to reduce the municipal budget deficit as revenue projections have decreased and attempts are being made to mitigate the effects of decreased aid. Finance Director, Liz Rourke goes through the updated plan that she states has been placed in tonight's meeting packet (see attached). Mr. Gilleberto states:

- Numbers are in flux and it is not clear what relief will be available from the State; the numbers will be a challenge to balance the municipal and school budgets.
- Will look at reductions necessary to getting closer to balancing the budget.

Following the power point presentation, the Board Members responded:

- Mr. O'Leary no questions.
- Mr. Wallner no questions.
- Mr. Schultz wants to explore using the rainy day funds to help fund the deficit, especially during the pandemic, and is hopeful the Town will have federal bailout money to make the budget work.
- Mr. O'Leary stated the rainy day fund will be needed next year.
- Mrs. Gonzalez would like to consider using some money from the rainy day fund.

Mr. Gilleberto states a deficit is being addressed in the School Department also. He wants the Community to be aware that the Finance Team is working within a challenging time and hopes to vote on the budget at the June 1<sup>st</sup> Select Board Meeting. He further stated the Plan was revised based on reductions being made in local receipts and Representative Jones informed him a 10% reduction in State aid should be anticipated. He further stated if Town Meeting is not able to take place on June 29<sup>th</sup> a 1-12 budget will have to be considered. Mrs. Manupelli is concerned that enough reductions may not have been projected and the budget will have to be revisited at October Town Meeting.

#### **DISCUSS SENDING LETTER IN SUPPORT OF MAIL-IN ELECTIONS**

Mr. O'Leary asked that this topic be placed on tonight's agenda for further discussion. He stated:

- Everyone should be provided a safe, accessible way to participate in the right to vote.
- Voting by mail is the safest, most convenient way to vote.
- Wants the Board to go on record to encourage State and Federal Legislatures to adopt voting by mail in the upcoming primary and November election.
- Several States are already doing this successfully.

#### Board Members responded:

- Mr. Wallner stated through his research he learned that voter turnout increased with Mail in Elections and supports writing a letter.

\_\_\_\_\_

- Mr. Schultz stated he would support it for Town election and the Primary, not National elections, he is concerned about fraud.
- Mrs. Gonzalez stated she is against it Nationally but she is okay with Local. She brought up the option of drive up voting. She would not sign a letter for National mail in voting.

Mrs. Manupelli invites Town Clerk Barbara Stats to "weigh in", Ms. Stats states:

- There is lots of legislation on this matter and a lot of issues with mail in ballots.
- Fraud is a concern.
- COVID19 is an acceptable reason for an absentee ballot.
- Other states have had time to put safeguards in place.
- There is a big effort for Wardens and Clerks to check in absentee ballots, and adding in mail out ballots causes concern for administering.

Mr. O'Leary reads the statistics on states that have mail in voting without fraud. He suggests using Bar codes to avoid duplicate ballots being cast. Mrs. Manupelli said to wait to see what the Legislature does with this. It was the consensus of the Board to support mail in ballots for local elections only.

#### TOWN ADMINISTRATOR'S REPORT

No written report. Mr. Gilleberto invited Water Superintendent, Mark Clark to give an update on the water quality notice that went out to the residents. He stated:

- Notice is similar to the notice sent in February.
- Testing is done more often.
- Enough Chlorine has been added so there is no bacteria growth.
- Has been working with the State and logically the levels will be coming down.
